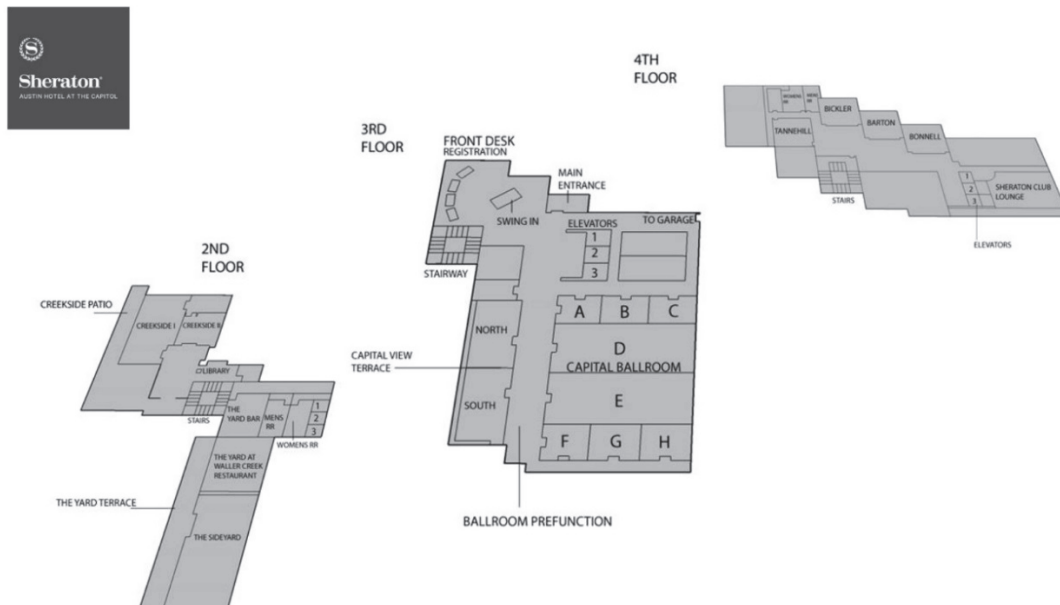

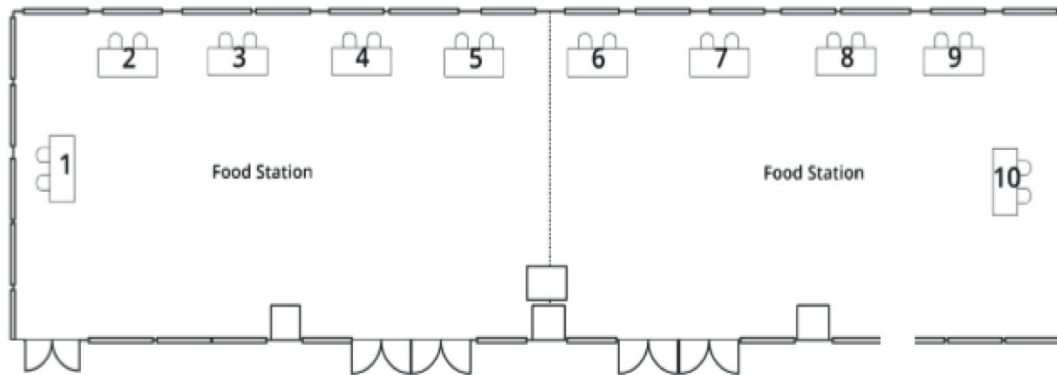

## **Paid Family and Sick Leave: The California Experience and a Federal Framework**

Paid Family Leave and paid sick leave have continued to be an issue as employees try to meet their work and family responsibilities. While many employers voluntarily offer various types of paid leave, some employers, particularly small business, cannot afford to provide paid leave to their employees. In this environment, four states have enacted paid family programs and 10 states now require employers to provide paid sick leave while still other states consider adopting similar paid leave requirements. The lack of consistent state and local policies across the nation have led to employer confusion and administrative burdens. In a tight labor market, employers seek ways to provide benefits to attract and retain workers. President Trump included a provision to pay for parental leave through the UI system as part of the FY 2018 and 2019 budget proposals and there continues to be interest in some additional federal response to this issue. In this session, you will hear about two different approaches - the California experience with state mandated family and sick leave policies, and a legislative proposal in Congress, sponsored by Representative Mimi Walters (R-CA), that allows employers that choose to offer a minimum threshold of paid leave and a flexible work option to all employees to automatically satisfy all state and local paid leave requirements.

There is an ongoing debate about the value of requiring employers to report occupation information as part of the UI quarterly wage reports. The quarterly UI wage report is not only used in performance evaluation for WIOA, but also has value in evaluating whether the education and training has value in filling the workforce needs of employers and enabling individuals to be assured that the education and training in which they enroll prepares them for jobs in demand. Some employers already participate in voluntary networks that are used to evaluate education and training as part of the hiring process. However, there is currently no nationwide source of uniform occupational data on all employees that may be accessed. Although some employers see value in a nationwide data base that includes uniform occupation information data, employers are generally not prepared to meet the added burden of determining occupational codes for every employee and submitting that information on a quarterly basis. The cost/benefit to most employers is not favorable. Still a number of states have required the reporting of occupation with UI quarterly reports. What have been the results of these state requirements on employers, state agencies, and on the availability of accurate and reliable occupation information?

## J. ELDRED HILL, JR. AWARD: GAY M. GILBERT

Gay Gilbert is among a very small number of individuals in the history of the UI Program to have had a profound impact on Unemployment Insurance in the United States. From her days as a UI Director and Deputy Administrator in Ohio to her career as US DOL Senior Executive Staff, Administrator of the Office of Workforce Investment, and Administrator of the Office of Unemployment Insurance, Gay has been the consummate professional in addressing the most difficult issues facing Unemployment Insurance and finding solutions.



Early in her career Gay lead the way in development of meaningful Unemployment Insurance program evaluation metrics, and in her role at the US Department of Labor she has demonstrated the commitment to continuous improvement to assure that the Unemployment Insurance system meets the needs of unemployed workers and connects them with employers.

Gay successfully advocated for improved and expanded Reemployment Services and Reemployment and Eligibility Assessments that have become a primary focus of the UI program.

Gay was a driving force in the development of the State Information Data Exchange System that is now the platform through which information is exchanged in the determination of unemployment compensation across the country. Determinations are rendered more quickly and more accurately to the benefit of unemployed workers and employers in large measure because of the work of Gay Gilbert.

In the area of program integrity, Gay was among the first to recognize that with increased automation and access through the internet there would be increased stress on the integrity of benefit payments and the threat of identity theft would be significant. Working with NASWA and the Office of Inspector General, Gay lead the development of the Integrity Center and initiatives to identify fraud and identity theft early and to avoid erroneous payments that would otherwise be charged to employer accounts.

Gay Gilbert led US DOL in coordinating the administrative response to dramatically increased unemployment in the Great Recession of 2008 and the seemingly endless changes in statutory requirements.

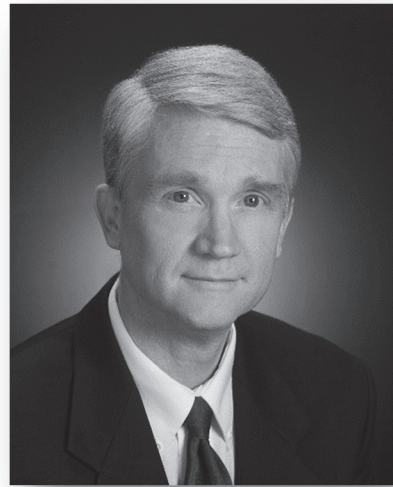
Gay's list of positions of responsibility for the Unemployment Insurance program alone would be worthy of recognition, but it is her personal integrity, strength of character, dedication and commitment that really set her apart as deserving of highest recognition. ## J. ELDRED HILL, JR. AWARD: WILLIAM T. (TOMMY) SIMMONS

For over 30 years, Mr. Simmons has served as an incredible champion for employers in his role as Senior Legal Counsel to the employer commissioner. In that time, he has given more than 2,000 presentations to employer groups in many different venues, including monthly Texas Business Conferences (TBC) held throughout the state. Mr. Simmons' institutional experience and profound knowledge of the state and federal Unemployment Insurance laws has been invaluable to Texas employers. He has worked with TWC commissioners to develop a model for other states to consider as a best practice in outreach and service to employers. Mr. Simmons' dedication to managing and maintaining the resources provided to businesses in Texas is fundamental to the success of the Texas Workforce Commission. He has worked tirelessly to respond to employer questions through the employer hotline and provides guidance on employment matters. He has conducted Texas Business Conferences, a series of employment law seminars for employers held each year throughout the state.



Mr. Simmons has provided valuable insight into employment law by authoring articles for the quarterly magazine *Texas Business Today*. The magazine is a free online informational newsletter covering issues and interests of Texas employers. Through this magazine, employers around the state write to Mr. Simmons with questions about employment law. - UC and Texas Payday Law Claims

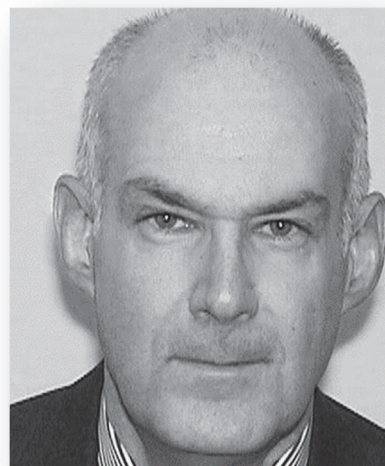

## UI INTEGRITY AWARD: JOSEPH MUELLER

Joseph Mueller has dedicated more than a quarter century of his life to the Illinois Department of Employment Security and the unemployment insurance system. He is the state's foremost expert on the UI system and is looked upon as a fair arbiter by both the business community and organized labor.

Mr. Mueller is the Chief Legal Counsel to the Illinois Department of Employment Security (IDES) - a role he has held for 27 years through Republican and Democratic administrations. As Chief Legal Counsel, he oversees the Office of Legal Counsel, the Board of Review, the Attorney General's Office Division which is embedded within the IDES, and the Division of Appeals. In the aggregate, Joe oversees 56 attorneys not including non-attorney support staff.



Illinois uses an "agreed bill process" under which business and labor meet every few years to negotiate changes to the Unemployment Insurance Act. The state has dealt with multi-billion deficits, bonding, and changes in the definition of misconduct, and other critical issues that impact employers and workers.

Mr. Mueller's service to the integrity of the UI system has expanded beyond Illinois to his work on various national committees for the National Governors' Association and the National Association of State Workforce Agencies. He played a key role in advocating for the state based UI system to amend federal law to assure that states had the authority to modify alternative base periods upon which to determine benefit eligibility.

Mr. Mueller for many years served as an expert presenter at the National UI Issues Conference hosted by the National Foundation for Unemployment Compensation and Workers' Compensation. He embodies all of the attributes that the award recognizes, and is truly deserving of this recognition. For the reasons noted above it is our pleasure to recognize Joseph Mueller with the UI Integrity Award.

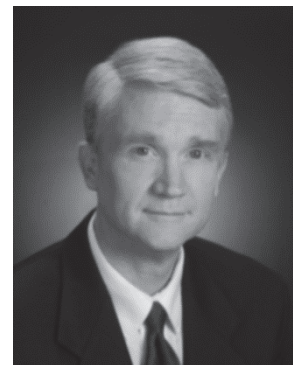

### **North Carolina Department of Commerce**

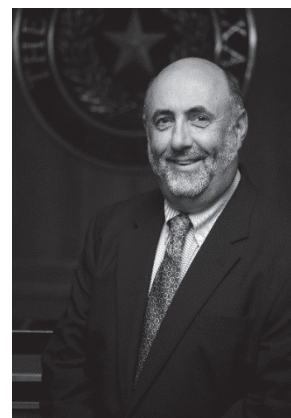

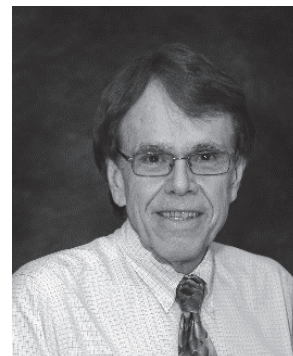
