

# What is the Michigan UIA Doing – A Summary

Identity Verification Procedures allow due process and quick resolution of any false positives

Michigan's approach is built around **communication with all interested parties** and resolution for victims. Fraud prevention, mitigation, and identification tools on the front-end and elsewhere throughout claim filing and certification identify fraudulent claims. Resolution for victims and valid claimants through proper notices is fundamental to our approach **working to resolution**.

Constant approach to identifying suspicious behavior of insiders with continued look-back

As reported by the United States Secret Service, and confirmed by banking executives, **domestic** and international crime rings are targeting UI programs. Bad actors will continue to attempt imposter fraud until sufficient controls and detection mechanisms are deployed. Biggest threat to Michigan after June 2020 was insiders.

Support has formalized our longstanding approach with a Fraud Task Force While rapid response can help to immediately reduce the payment of fraudulent applications, bad actors will continue to evolve in their approach to evade controls. UIPL 16-20, Change 5 urges states to "have aggressive strategies and tools in place to prevent, detect, and recover fraudulent payments, with a particular emphasis on imposter fraud." Executive Order by Michigan Governor formalized our Fraud Task Force and secured additional funding.

**SUBJECT:** Identity Verification for Unemployment Insurance (UI) Claims

Purpose. To highlight the importance of identity verification in ensuring the proper payment
of unemployment benefits and to provide guidance to states on required administrative
procedures when processing claims and determining UI eligibility in cases where an
individual's identity (ID) is questionable.

## 4. Claims Determination Processes Related to ID Verification.

When a state obtains information through automated systems or other sources that question whether the name and/or SSN used to file a claim belong to the individual who is filing the claim, the state must act quickly to: i) provide the individual with proper notice and an opportunity to provide information to resolve the issue; ii) decide whether or not sufficient information has been provided to verify the individual's ID; and iii) issue a written determination. The notice must also include information that failure to respond could result in a determination denying benefits and establishing an overpayment of any benefits previously paid. These processes must be consistent with the adjudication standards of sections 303(a)(1) and 303(a)(3) of the SSA (42 U.S.C. 503(a)(1) and (3)), and the CD (20 C.F.R. Part 614, Appendix B).

### Why you are receiving this?

Due to high levels of fraud across the country, all individuals must establish their identity to receive unemployment benefits. Some activity on your account was flagged and the Unemployment Insurance Agency (UIA) cannot verify your identity. We need to verify your identity for you to receive unemployment insurance benefits.

### ACTION REQUIRED

By July 05, 2022, we need you to submit the following documents (separately):

- Signed and dated Form UIA 6347 (this form)
- 2. Identification document(s) (front and back copies required), see page 2 for details.

For faster service, submit these documents by logging in to your Michigan Web Account Manager (MiWAM) and clicking on the "Verify Identity" link located under Alerts. You can also submit the documents via mail or fax.

Late or incomplete submissions can lead to delayed payments. Additional guidelines of which documents to submit and how to submit them are on the next page.

After submitting the identity documentation, your documents will be reviewed. Once your identity is verified, the "Stop Payment" notice will be removed. If your identity cannot be verified based on the documents submitted, you will receive a determination that you are not eligible for benefits because your identity could not be verified. Instruction on how to protest the determination will also be provided.

Certification: I certify that the information I have reported is true and correct. I understand that if I intentionally make a false statement, misrepresent facts or conceal material information to obtain benefits, I may be required to repay benefits, charged penalties and could be subject to criminal prosecution.

In addition to signed copy of this form, we need you to submit one document from List A (Option 1) or one document from List B and one from List C (Option 2), see a list of documents below. If the name on the unemployment claim does not match the name on your ID documents, you must provide proof of your name change (e.g., marriage license, divorce decree, or court order document).

Submit a photo of yourself holding your ID documents. This can be a selfie of yourself holding the identification documentation or someone can take the photo of you. Your full face and the full ID must be visible. This will help UIA review your claim guicker.

## **Insider Threat Monitoring**

Analyzed weekly claims against internal IP addresses, account touches, and discarded cases to identify potential insider threats

Developed a three-ponged approach to proactively identify potential insider threats




**IP Address Matches:** Analyzed claimant web activity against IP addresses utilized by internal users



**Account Touches:** Examined occurrences of internal users touching the claim(s); matched data to our in-contact call center data; utilized account notes; time spent performing activity on claim



**Discarded Cases:** Compiled the number of discarded cases each internal user has performed; number of adjudications performed on claims with similar attributes

Tracked notes left on discarded cases by internal users to identify additional potentially fraudulent claims

# Roadmap to Success – Insider Threat Monitoring

## **Business Processes**

Policies, communications, and training that govern the mitigation of insider risks, set behavioral expectations, and ensure consistent enforcement:



Define roles and map access to given roles and responsibilities



Develop a framework based on roles, unique threats, and risk tolerance to proactively stop or disrupt emerging insider threats



Create a roadmap that highlights phases to develop an insider threat program as part of the state workforce agency's risk mitigation strategy

## **Analytics**

Leverage advanced analytics to identify anomalies, analyze networks, and apply a risk-based approach:



Leverage existing analyses (anomaly detection, network analysis) to provide a foundation for more advanced techniques



Develop predictive models to proactively identify and mitigate fraud



Build reporting dashboards to review high-risk internal users and provide tactical and strategic views to address challenges

## Technology

Technological landscape and software tools that operate the program as well as house the data:



Review and enhance the state workforce agencies current access and identity management policies and practices



Establish a well-defined third-party risk management program to proactively manage third party security risks



Implement technology and controls to harden the network, detect potential insiders and respond to threats

UIA maintains long-standing relationships with DOL-OIG and federal enforcement agencies; providing critical support in the federal prosecution of approximately 60 individuals to-date (more cases pending)


